AGREEMENT TO TERMS

These Terms of Use constitute a legally binding agreement made between you, whether personally or on behalf of an entity (“you”) and ICI Technologies LLC (“**Company**”, “**we**”, “**us**”, or “**our**”), concerning your access to and use of the www.delivrmat.com website as well as any other media form, media channel, mobile website or mobile application related, linked, or otherwise connected thereto (collectively, the “Site”). You agree that by accessing the Site, you have read, understood, and agreed to be bound by all of these Terms of Use. IF YOU DO NOT AGREE WITH ALL OF THESE TERMS OF USE, THEN YOU ARE EXPRESSLY PROHIBITED FROM USING THE SITE AND YOU MUST DISCONTINUE USE IMMEDIATELY.

Supplemental terms and conditions or documents that may be posted on the Site from time to time are hereby expressly incorporated herein by reference. We reserve the right, in our sole discretion, to make changes or modifications to these Terms of Use at any time and for any reason. We will alert you about any changes by updating the “Last updated” date of these Terms of Use, and you waive any right to receive specific notice of each such change. DELIVRMAT LAUNDRY DELIVERY SERVICE

The goal of Delivrmat - ICI Technologies LLC and our partnering laundromats is to process each and every item with the utmost care in a timely fashion. We employ modern equipment and techniques giving each laundered or dry-cleaned item individual attention.

By signing up with Delivrmat - ICI Technologies LLC and opening your online account, you agree to the following terms and conditions. These terms and conditions are subject to change and it is the responsibility of you, the customer, to review these terms prior purchase of any services.

User & Laundromat Laundry Service Agreement

If you are not 100% pleased with our services, if any of your items are missing, or to report any damage to your garments, you must contact our customer service number department at 205-259-8722 or email contactus@delivrmat.com within 24 hours of your final delivery date. After this period, no refunds will be given, or claims responded to.

Our drop off wash, dry, and fold service has a minimum \$15 item total. Our laundry pickup and/or delivery service minimum fee is \$2.50. An additional service fee will be applied to orders that do not reach the minimum amount. Laundromats reserve the right to change the rate of their service at any time.

Delivmat - ICI Technologies LLC will charge partnering laundromats a monthly fee of \$10 to use of the online platform. We will also charge partnering laundromats 20% of the item total for each order. There is a minimum amount of \$100 for partnering laundromats to transfer their balances over to their Stripe Payment accounts. Delivmat - ICI Technologies LLC reserves the right to change the rate of their service at any time.

The bags will be weighed at one of Delivmat's partnering laundromats and we reserve the right to automatically bill the credit or debit card you have provided for your purchase. Delivmat - ICI Technologies LLC and partnering laundromats will not honor any weighing disputes and we do not give any refunds for claims involving load weight. Customers must supply their own laundry bag which can be closed with a zipper, drawstring, or Velcro. All items not in closed bags forfeit any loss claims of loss for your entire order. Any baskets, hampers or other containers will be weighed together with their contents and you will be charged for this weight at the same rate as your laundered items.

Damaged Clothes

Delivmat's partnering laundromats, individually inspect every item at their facility before and after they are processed and do their best to find any items that may have been forgotten by a customer in pockets or other areas of the laundry. However, Delivmat – ICI Technologies LLC and Delivmat's partnering laundromats are not responsible for any items left in pockets such as pens or other items which may harm laundry during the washing or drying processes. Additionally, any items which are purposely torn or damaged such as jeans, denim garments, etc. by the manufacturer of the garment or the customer can never be included in any damage claim for any reason.

All of our partnering laundromats wash, dry and fold cycles use cold washes unless requested. This means that we will never honor any claims of shrinking, color fading, or color blending. These are all normal occurrences to some degree in all laundry processes and will never be considered a form of damage by Delivmat – ICI Technologies LLC or our partnering laundromats. Additionally, some stains cannot be removed in a cold wash. We do not promise to remove any stain but make sure to adequately spot treat any stain prior to washing and re-check the stain before drying.

There are some stains that do not appear until exposed to water or heat. Such stains typically have a sugar base. Examples of such stains are alcohol and juices. These stains can be proved in a laboratory. This testing is expensive, often in excess of \$250. Should a stain damage claim be made, Delivmat - ICI Technologies LLC will send the item in question for laboratory testing. Should it be

determined that Delivrmat - ICI Technologies LLC or one of our partnering laundromats are responsible for the stain damage in question, Delivrmat - ICI Technologies LLC will assume the testing charge and make suitable remuneration for the item or items up to a combined value of \$150. Should the laboratory determine that the stain or discoloration is sugar based that was not apparent prior to exposure to heat and/or water the customer assumes all responsibility for lab fees and will not be remunerated for the damaged item. No garment will ever be sent for testing without the express written consent of the customer and a fully refundable testing deposit of \$250 be made by the customer. Should the item be shown to have been damaged by Delivrmat - ICI Technologies LLC or one of our partnering laundromats the testing deposit will be immediate refunded. Delivrmat - ICI Technologies LLC and our partnering laundromats do not use sugar-based stains as an escape clause for damaged items due to the ease with which an expert can identify the cause of a stain.

By putting any item into your laundry or dry-cleaning bags, you are guaranteeing ownership and responsibility of that item. We highly recommend not including items that do not belong to you such as your roommates' or friends' to avoid any conflict. If another party really needs a specific item to be washed, have them set up a separate account.

Missing Items

If you wish to report a missing or stolen item, you must be able to provide a specific description of the item such as the type of garment, brand, color, size. While we will investigate any claim of stolen or missing items to the best of our ability, we do not offer any compensation for missing or stolen items. As our partnering laundromats take care in individually handling and sorting garments, we find that the vast majority of claims are in fact the fault of the customer misplacing or simply not including a garment that they thought was in their laundry bag. We recommend including a detailed list of all items in the bag which will be checked upon reaching one of our partnering laundromat's facility if this is a concern. This list will not be considered a formal form of inventory, but it will help us to identify the items you include.

Delivrmat's partnering laundromats carefully check all items for damages, contents, and total weight. This happens before and after the wash-dry-fold and dry-cleaning process. We accept no financial responsibility for any items left in the customer's garments. We check for any items such as ink pens, markers, highlighters, makeup, or other items which may cause serious damage to your garments but accept no responsibility for damages that are caused by these items. The best way to ensure that these damages never occur is to do what we do before you leave it in our care. Check each individual item before putting it in the laundry or dry-cleaning bag; even if it doesn't have pockets. And also, double check to make sure nothing other than your garments found its way into your laundry or dry cleaning bag.

While we try as hard as we can to make our service as convenient for you as possible, we do not

accept responsibility for items lost or stolen if they are left for pickup or delivery at a pre-designated area rather than a hand to hand exchange from customer to driver.

Once you have placed an order with Delivrmat – ICI Technologies LLC and schedule a pickup or delivery, you cannot change any services on the order. To avoid any conflict, please make sure you schedule the job you want us to do carefully so we can meet your needs to the best of our abilities.

Reimbursement

Wash Dry Fold Policy: Delivrmat - ICI Technologies LLC and partnering laundromats will not cover any reimbursement over \$200 total or any individual item over \$20. Delivrmat - ICI Technologies LLC reserves the sole right to decide if any reimbursement will be in cash or credit toward for future services.

Dry Cleaning: Delivrmat - ICI Technologies LLC and partnering laundromats exercises the utmost care in processing articles entrusted to us and use such processes which, in our opinion are the best suited to the nature and condition of each individual article. Nevertheless, we cannot assume responsibility for inherent weaknesses of or defects in materials that are not readily apparent prior to processing. This applies particularly, but not exclusively, to suede, leathers, silks, satins, double face fabrics, vinyl, polyurethane and other fragile materials. Responsibility also is disclaimed for trimmings, buckles, belts, beads, buttons, and sequins. We cannot guarantee against color loss and shrinkage or against damage to weak and fragile fabrics in the laundering or dry-cleaning process. Differences in count must be reported within 24 hours. Unless a list accompanied your order, our count must be accepted. The company's liability with respect to any lost article shall not exceed 10 times our charge for processing it.

General Terms

Delivrmat - ICI Technologies LLC reserves the right to change these terms at any time and refuse service to any customer. Our partnering laundromat's operating information such as prices and operating hours can be found on the Delivrmat app. If any necessary information is missing for a customer's account, we reserve the right to refuse service. The customer agrees to provide a valid credit card prior to pickup and delivery service. It is the responsibility of the customer to inform Delivrmat - ICI Technologies LLC of any changes to credit card numbers and expiration dates. Delivrmat - ICI Technologies LLC does not charge your account until your laundry has been delivered. If we fail to successfully charge your credit card, then our partnering laundromat will hold your laundry until your card is successfully charged.

Delivrmat - ICI Technologies LLC also reserves the right to cancel any order and issue a full refund of any money spent on said order if there is a pricing error or website glitch which led to improper payment amounts received. Delivrmat - ICI Technologies LLC also is not responsible for any monthly

services started by a user. It is the user's sole responsibility to start and stop these services and any failure to do so will not result in a refund from Delivmat - ICI Technologies LLC.

Due to the unpredictability of weather conditions in Delivmat's markets at certain times of the year, Delivmat - ICI Technologies LLC reserves the right to make any pickup or delivery cancellations for the safety of our drivers. Contact will be made with the customer as soon as possible so that a future pickup or delivery may be made. All attempts will be made to honor the original pickup and delivery times before resorting to a schedule change.

Use License
